

Congratulations on your purchase of a CapstanAG EVO™ system!

Capstan Ag Systems, Inc. (hereinafter referred to as "Capstan Ag") as the manufacturer of the system, offers a standard warranty on the EVO™ System and its covered parts as defined below (collectively as the "EVO System"), warranting that the EVO System is manufactured free from defects in material and workmanship for the time period of 1 year from the date of system installation. All systems are tested to ensure function and quality prior to shipping.

PURCHASING EXTENDED WARRANTY

New for the EVO System, Capstan Ag is offering a limited annual extended warranty ("the Extended Warranty") that can be purchased each year for \$500 USD to extend the standard warranty coverage of manufacturing defects in the electronic components of the system for an additional 12 months. The Extended Warranty may be purchased at the time of the original system sale and will extend the factory standard warranty for an additional 12 months beyond the factory standard warranty for a total of 24 months of coverage. A total of 2 years of extended warranty coverage may be purchased, at the rate of \$500 USD per year, upon the purchase of the system bringing the possible number of years of warranty coverage to 3 years.

The price for the full 2 years of extended warranty will be \$1,000 USD. A \$200.00 USD deductible per warranty claim is to be managed and collected by the servicing dealer which will go into effect during the first year of the extended warranty period. The warranty is transferable in the event that the system or machine with the system is sold. The transferable coverage is contingent upon the new owner submitting a new warranty registration with the machine and system details for tracking purposes.

WARRANTY COVERAGE

The Extended Warranty only covers manufacturing-related defects in material and/or workmanship of the EVO System as determined by Capstan Ag in its exclusive discretion. The Extended Warranty does not cover EVO System failures, whether involving covered parts or non-covered parts, if such failure is caused by any act, event, factor, or circumstance that is beyond Capstan Ag's reasonable control and the damage to the EVO System is not related to a material and/or workmanship defect. 1 Covered Parts are exclusively the parts listed below in Schedule A. Nonexclusive examples of Non-Covered Parts or wear items are listed below in Schedule B. The proper maintenance of the EVO System in accordance with the operation and service guidelines in the product manual is the responsibility of the EVO System owner.

Under the Extended Warranty, Capstan Ag's sole obligations and the EVO System Owner's sole remedy for any covered part failure determined to be caused by a manufacturing defect in material or workmanship, as determined by Capstan Ag in its exclusive discretion, shall be limited to repair or replacement at Capstan Ag's option. Replacement, at Capstan Ag's option, may constitute a new, refurbished, or functionally equivalent item.

¹ Examples of non-covered events include misuse, improper operation, repair, or maintenance of the EVO System by the owner or any user or third party; civil unrest; war; governmental act; terrorist act; natural events and phenomena; and any other act, event, factor, or circumstance not caused or created by Capstan Ag and occurring after the EVO System left Capstan Ag's control, whether similar or dissimilar to any of the foregoing.



WARRANTY CLAIM SUBMISSION

Within 30 days of any failure of a covered part on the EVO System, the failed covered part must be submitted to Capstan Ag for claim evaluation, together with a completed claim form, available at capstanag.com, that identifies the part number, as listed in Schedule A below, of the failed covered part; if applicable, the failed covered part's serial number; and the covered failure event. Claims for non-covered parts, non-covered failures, and failed covered parts returned to Capstan Ag more than 30 days after claim form submission will be denied. Claim submissions, including the failed covered part being returned for claim evaluation, will be shipped to Capstan Ag at the owner's expense.

Risk of loss for any failed parts returned to Capstan Ag will be exclusively the EVO System owner's, until receipt of such parts by Capstan Ag. In the case of non-covered parts being returned with covered parts, warranty coverage will only be approved for the failed covered part(s) and the non-covered parts will be returned in the condition and state they were received by Capstan Ag, at the owner's expense, to the owner.

THIS WARRANTY EXCLUSIVE AND EXTENDED BY CAPSTAN AG IN LIEU OF ALL OTHER WARRANTIES, EITHER EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, TO THE EXTENT THAT THE APPLICABLE LAW ALLOWS THE EXCLUSION OF IMPLIED WARRANTIES, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES.
